I agree:

- To obey all interactions as to the speed and manner of riding given to me by the power of the horse, have read and agree to all provisions outlined within the owner's (Granger Brookland Farm's) Usage and Courtesy Rules.
- That the usage of a flack jacket, chaps or leggings will decrease the risk of my getting injured and that I will make my own informed decision regarding the usage of such protection.
- To hold the owner harmless of any action of third parties that could have an adverse influence on the horse I am riding or me.
- To having inspected the equipment being used on the horse I am riding and have determined that this equipment is appropriate for my dimensions and riding skills.
- To take full responsibility for any and all consequence resulting from my contact with the owner's horses and not to hold the owner liable in the event of injury to the rider or to others resulting from the use of the animal by the rider.
- That any part of this agreement should be deemed invalid, such part shall be severed, and the remaining provisions shall nevertheless continue in full force and effect.
- That in the event that litigation becomes necessary, the county of Ingham, within the state of Michigan, will be the location for a trial.
